## **Community Accomplishments**

- GHPOA has re-signed a contract with Community Association Services of IN (CASI) to provide
  property management services for GHPOA. This followed a period of due diligence where
  bids from other vendors were thoroughly vetted. Following the same process, the snow
  removal contract was also let out to bid, and Oasis Outdoor Living was selected, once again,
  as our snow removal contractor
- Painting and repair of our street signs and poles has been completed.
- YTD, our newly formed Welcome Committee has delivered welcome packets to approximately 75 new property owners.
- The Social Committee researched and organized our new "Here Comes Santa" event which was then presented to the Board for approval
- The landscape beds in Admirals Woods have been refurbished.
- After careful analysis and support from a majority of responding Masthead residents, GHPOA has contracted with IPL and Duke Energy to install street lighting at specific Masthead entrances.
