Annual Meeting

Our Annual Meeting was held on Tuesday, January 17th, at Amy Beverland School. 49 property owners attended in-person and 26 participated online. In addition, 104 property owners submitted proxies. Our Treasurer, Geist Patrol and all Committee Chairs presented a recap of 2022 accomplishments and plans for 2023. A Q&A session followed the meeting. Unfortunately, the City Councilors from Indianapolis (Ali Brown) and Fishers (Pete Peterson) were unable to attend the meeting as their presence was required at city council meetings. David Hofmann, Deputy Mayor of Lawrence, did attend.

Responsibility, Maintenance and Repair of Sidewalks

A question was raised at our Annual Meeting regarding ownership of GHPOA sidewalks. Numerous GHPOA sidewalks are urgently in need of repair. Indiana Homeowner Association law states that Association dues may only be spent to repair, improve or replace assets owned by the Association. The responsibility for sidewalk repair and maintenance has been carefully researched. All GHPOA sidewalks located in Marion County are the responsibility Indianapolis and Lawrence. Per an ordinance passed by Fishers, the property owner adjacent to the sidewalk is responsible for repair and maintenance. Therefore, GHPOA is unable to use Association dues to pay for any sidewalk repair or maintenance. To report damaged, missing or uneven sidewalks in Indianapolis, contact the Mayor's Action Center (https://www.indy.gov/agency/mayors-action-center) or call 317-327-4622. In Lawrence, visit https://www.cityoflawrence.org/report-potholes and complete the "Contact Us" form, selecting streets and sidewalks from the drop-down menu.

Immediately contact Geist Patrol at 317-842-8082 to report any suspicious person, vehicle or activity. They are always available to assist GHPOA residents.

Emergency on your property? By providing Geist Patrol with your emergency contact information (phone and email), they can immediately notify you of any emergency. You are encouraged to visit their website (Geist Patrol.com) and provide this information. Geist Patrol will never sell you information and would only share it with law enforcement agencies in exigent circumstances.
