### **LEGAL RESPONSIBILITY OF PET OWNERS**

Dog bites are a continuing concern. Per Fishers, Indianapolis, and Lawrence Ordinances, it is the responsibility of pet owners to maintain control of their animals at all times either by securing them in a pen, cage, yard or by use of a leash. Pet owners who fail to maintain control of their animals are subject to warnings, citations, fines, or other legal action. In addition, individuals have the legal right to carry mace or pepper spray (such as Capstun).

### **AUTUMN LEAVES WILL SOON BE FALLNG!**

<u>Burning leaves is illegal in Fishers, Indianapolis, and Lawrence!</u> The fumes are a health risk to children and adults with lung conditions. Please bag your leaves and put them out for collection. Please contact Geist Patrol at 317-842-8082 to report burning leaves.

<u>Fishers</u> – During the month of November, Republic will collect a maximum of 20 bags of yard waste per household. Please use compostable bags. In addition, 3x3 bundles of branches or twigs will be collected. Collection occurs on your regular trash day.

<u>Indianapolis</u> – As of the printing of this newsletter, Indianapolis has not published the dates for leaf collection. Please visit <u>indy.gov/activity/leaf-collection-season</u> for an update.

<u>City of Lawrence</u> - During the month of November, residents may bag a maximum of 15 bags of yard waste. Collection will occur on your regular trash day.

Dear Residents.

Geist Patrol has recently acquired software which will provide area residents with the opportunity to register their security cameras via the "citizen registry" portal. Once registered, Geist Patrol will be able to compile a list of available area cameras to assist in those situations where security footage may be of value. If a crime or security related incident were to occur in your neighborhood, we would then be able to contact you and request pertinent video for the specific timeframe of the incident. The process for uploading videos into the system is quick and convenient.

To be sure, this <u>WILL NOT</u> give Geist Patrol (or anyone else) access to your camera(s) and/or security system. This will only provide our officers with a mechanism to request footage directly from you should the need arise. Our primary focus is your safety and as you know surveillance video plays a key role in reducing and deterring crime.
