Annual Meeting

The Association held its Annual Meeting on Tuesday, January 21st, at Amy Beverland Elementary School. Property owners elected the following Directors: Admirals Bay-Gus Levengood, Admirals Woods-Ralph Scott, Feather Cove II-Linda Esposito, and Masthead II-Sandra Richard. Forty-nine property owners attended the meeting and forty-five people attended online. In addition, the Board announced that a Town Hall Meeting will be held on February 11th to discuss a proposed covenant amendment to restrict short- and long-term leasing. City Councilors from Fishers, Indianapolis and the City of Lawrence were invited to attend. Indianapolis Councilor, Nick Roberts, and Lawrence Councilor, Kristie Krone, attended. Fishers Councilor, Pete Peterson, was unable to attend due to another commitment. A Q&A session followed the meeting.

The installation of an approved mailbox does not require submission of a Development Control Application.

A fully Completed Development Control Application must be submitted for review and approval for all proposed exterior changes to your home or lot!
